

WHAT IS A SECURE PORK SUPPLY PLAN?

Protect your herd

- The Secure Pork Supply (SPS) Plan is a written document that will be distributed company or farm wide. A complete SPS plan includes policies & procedures that focus on enhanced biosecurity measures tailored to your farm.
- The documents can be used to assist in preventing or managing an outbreak.
- The program is voluntary and provides an opportunity to prepare ahead of time for a disease outbreak.

WHY SHOULD YOU COMPLETE A SECURE PORK SUPPLY PLAN?

Preparedness

- **Business continuity:** during a disease outbreak, having an SPS Plan may allow for easier movement of livestock to processing or markets.
- **Biosecurity:** SPS Plans provide an opportunity for you to work proactively with your herd veterinarians and staff on an enhanced biosecurity plan.
- **Herd health:** SPS Plans provide biosecurity tools to catch diseases or sicknesses early, hopefully limiting its spread.

MAINTAINING BUSINESS CONTINUITY

During a foreign animal disease outbreak, such as foot and mouth disease (FMD), classical swine fever (CSF) or African swine fever (ASF), regulatory officials may impose movement restrictions on animals and animal products. Moving animals during an outbreak will then require a movement permit.

Movement permits may be easier to obtain if you have a completed Secure Pork Supply Plan. It is advised that producers complete these steps before a disease outbreak. A complete plan should include at minimum:

- 1 **Request or validate your Premises Identification Number (PIN)** from the Missouri Department of Agriculture and verify that your data includes a valid 911 address.
- 2 **Create a premises map** using an aerial map of your facility, showing areas of enhanced biosecurity protocols like cleaning and disinfection stations.
- 3 **Develop a site-specific, enhanced biosecurity plan and checklist.** The enhanced biosecurity checklist will be needed for permitted movement in and out of a control area.

Movement records are critical documents used to help animal health officials trace disease movement throughout the state, protecting your fellow producers.

Animal disposal can be complex in mass mortality situations. Planning ahead for acceptable disposal methods is critical.

- **Movement records:** animal, visitor, vehicle and equipment logs.
- **Biosecurity forms:** employee and visitor agreements, cleaning and disinfection inventory log
- **Disease monitoring plans:** daily observation log and emergency plans
- **Standard operating procedures:** establishing and operating the cleaning and disinfection station
- **Training logs:** group training records and individual training records
- **Signs and posters:** biosecurity signage in both English and Spanish.
